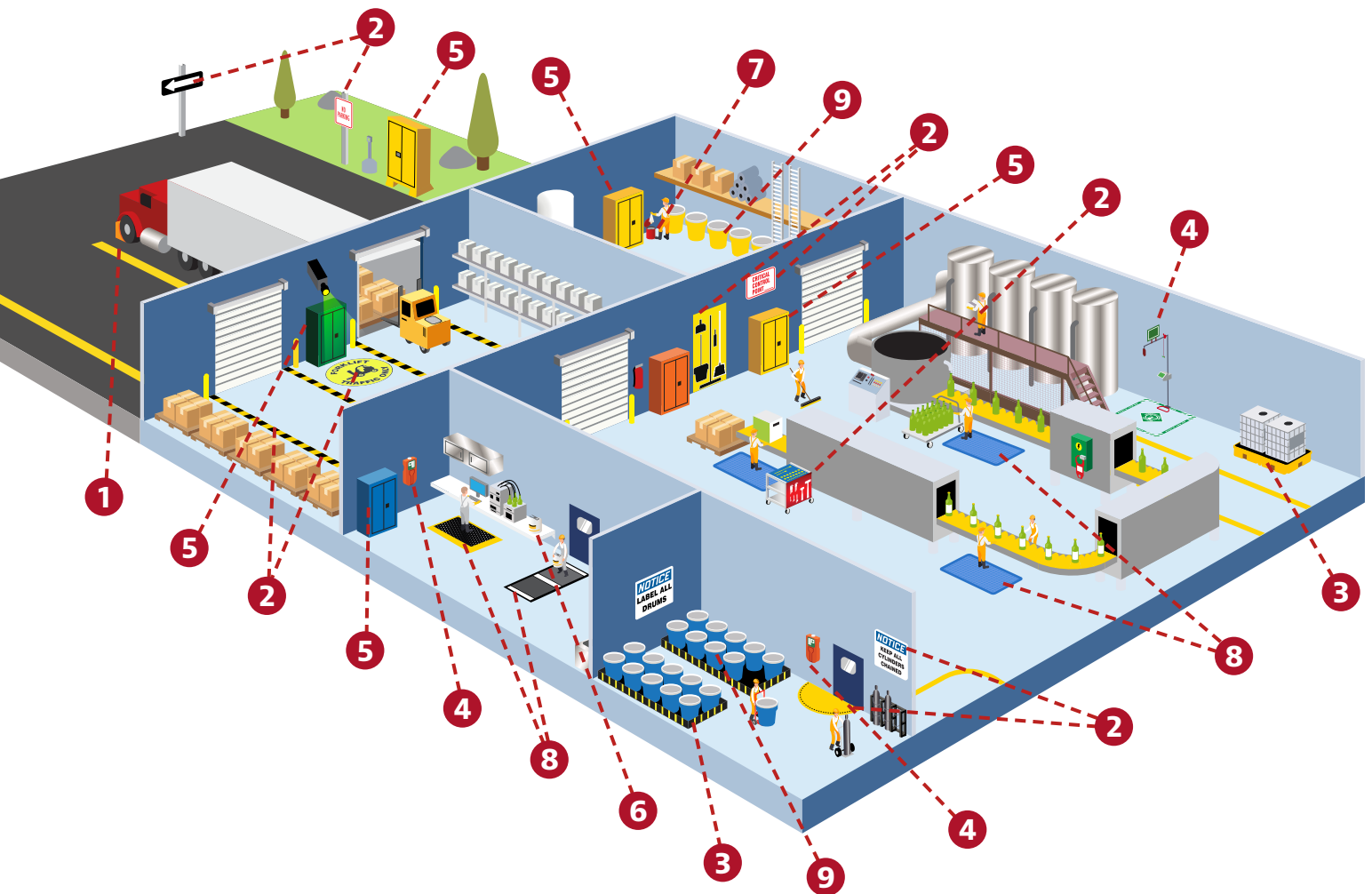

# Food and Beverage Workplace Safety Solutions



## Chemical Storage

Storing chemicals properly can prevent chemical hazards from your HACCP plan. Use OSHA compliant, fire-resistant safety cabinets to safely store flammable, hazardous and corrosive materials.



## Floor Matting

Anti-fatigue matting with ergonomic features keeps workers safe and productive. Long run and workstation options available, as well as sanitizing mats to avoid cross-contamination when entering clean rooms.



## Emergency Shower and Eye Wash

Chemicals for sanitizing and cleaning can cause serious damage to eyes and skin. Provide emergency response in the event of a chemical exposure or flushing for dirt and dust. To ensure compliance with ANSI, locate emergency equipment within an unobstructed 10-sec or 55-ft walk from where hazards may occur.



## Safety Identification

Appropriate signage and 5S solutions can help prohibit cross-contamination. Communicate biological, chemical, and physical hazards in the food processing plant. Custom solutions available.



## Secondary Spill Containment

From cooking oils to oil fueled machines, keeping multiple oils in the workplace comes with a high risk of spillage. Avoid fines from EPA and SPCC for water contamination and prevent slips and falls from accidental spills and leaks.



## Laboratory Waste Safety Cans

Common solvents (acetonitrile, hexane, and methanol) are flammable liquids used in the HPLC process. To comply with EPA regulations and keep employees safe, Justrite HPLC waste cans are essential, and the only FM approved safety can for collecting and disposing of flammable liquid waste from the HPLC process.

## Don't forget these important safety products:

- **Traffic Safety Signs** – control pedestrian and vehicle traffic flow
- **Floor Marking Tape** – mark designated locations
- **LOTO** – make equipment inoperable to prevent accidental startup
- **Wheel Chocks** – prevent vehicles from accidental movement
- **Oily Waste Cans** – safely dispose of soiled rags
- **Gas Cylinder Storage & Handling** – safely handle LPG cylinders
- **Projector Signs** – use where conventional signs are not applicable
- **Poly Drums** – keep materials fresh or dispose of hazardous waste
