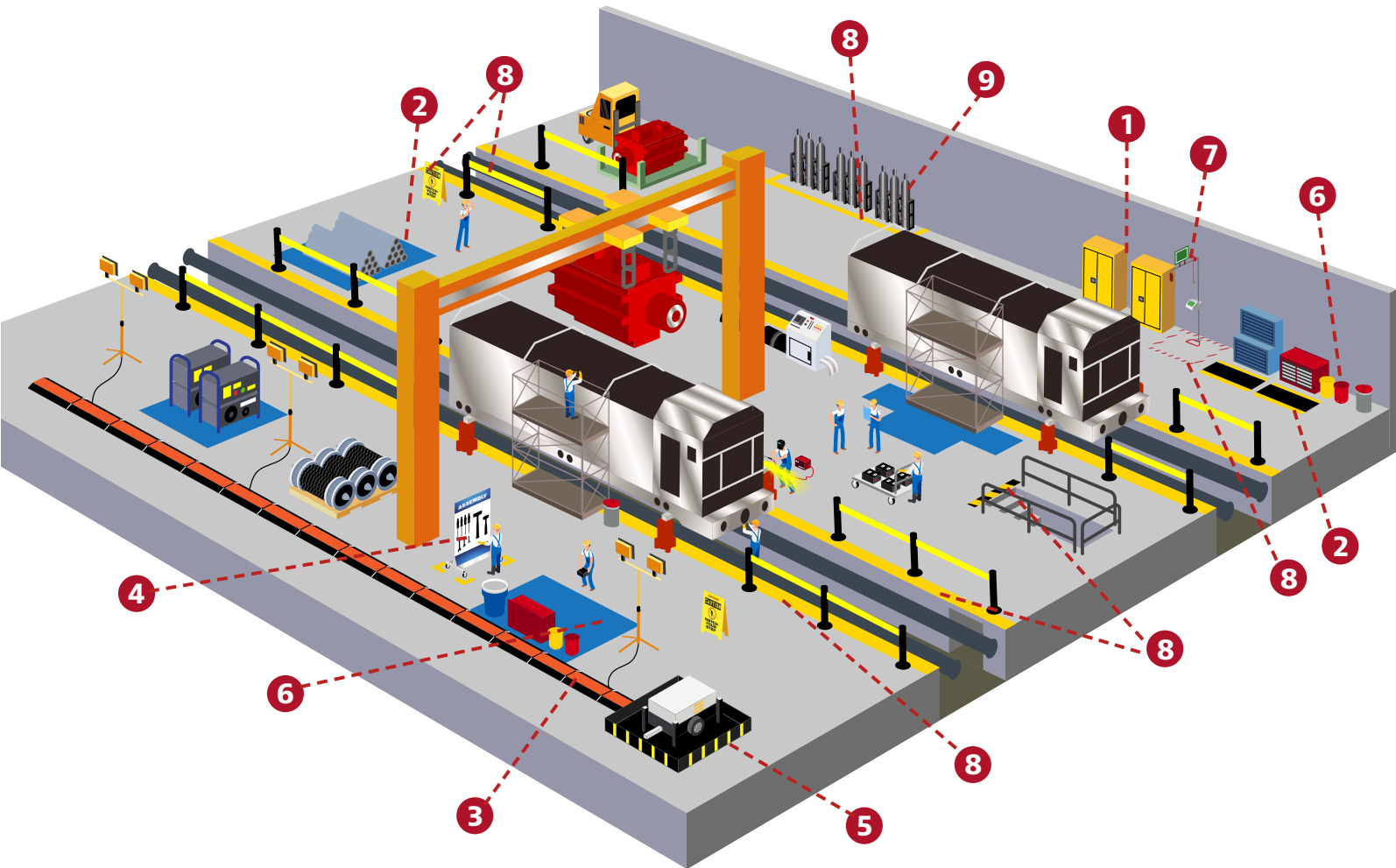

Manufacturing Safety Map

Creating a safe manufacturing environment is key to protecting workers, staying productive, and meeting compliance. This visual guide helps you spot gaps and apply effective solutions—from the production floor to the loading dock.



- 1 Safety Cabinet**
Securely stores flammable or hazardous materials, preventing accidents.
- 2 Floor Matting**
Improves traction, reduces fatigue, and prevents slips and falls.
- 3 Cable Protectors**
Cable protectors prevent trips, protect cables, and ensure a safe manufacturing area.
- 4 Shadow Board**
Shadow boards support 5S by organizing tools, eliminating clutter, and improving efficiency.
- 5 Secondary Spill Containment**
Secondary spill containment prevents hazardous spills, protects workers, and ensures environmental safety.
- 6 Oily Waste Cans & Drum Lids**
Safely contains and disposes of flammable rags and materials.
- 7 Emergency Shower & Eye Wash**
Emergency showers and eye washes provide immediate decontamination to protect workers from chemical exposure.
- 8 Floor Marking**
Floor markings highlight hazardous areas, mark emergency exits, and define pedestrian walkways, reducing the risk of accidents and injuries.
- 9 Gas Cylinder Storage & Handling**
Organizes gas cylinders, ensures safety, and prevents leaks.

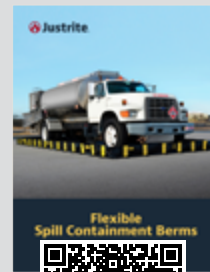

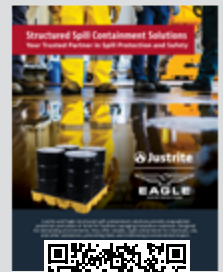
